Verify Quality Standards: To teach participants how to identify and verify standard quality marks (e.g., ISI, ISO, Agmark, FSSAI) before purchasing.

Inculcate Responsibilities: To highlight the duties of a consumer, such as demanding receipts, reading product labels, and inspecting expiry dates.

Spread awareness: After knowing all these aspects, students of law shall become able to spread awareness about consumer rights in the society.

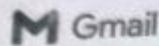

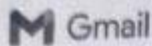

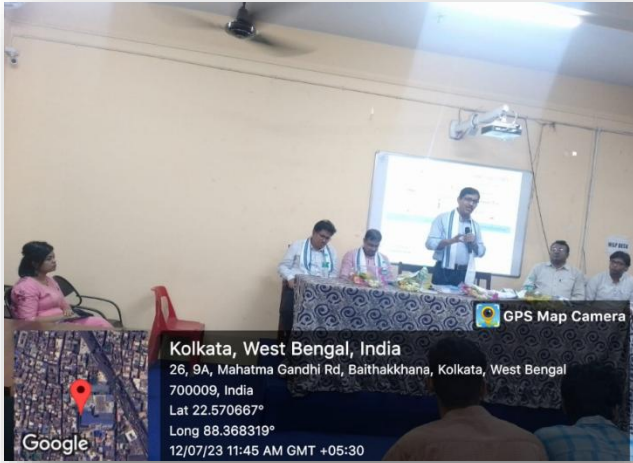
