About College and program: -

Surendranath Law college, an esteemed law college affiliated to Calcutta University since 1885, imparting UG and later on PG courses in Law has organized a Food camp in collaboration with The HAND on 24th September' 2022.

The NGO The HAND is connected with various social activities imparting free education amongst backward classes. It also extends Legal aid camp with Food distribution. Teachers Council and IQAC of SURENDRANATH LAW COLLEGE has shared Golden hands with this organization signing MOU. We are part of this organization and organizes a monthly Food distribution camp for more than a year.

OBJECTIVE: To provide healthy, sumptuous food item to family members of patient admitted at Chittaranjan Hospital. A voluntary service to serve a dinner to the needy persons in surrounding locality area.

BENEFITS: After a tiresome, hectic day of care giving to patient, they need protein rich food which is cooked safely hygienically by expert cooks. Not only patient parties but other needy people. About 500 people is benefited from this camp.

PROGRAM DETAILS: The camp carries three huge containers of Khichri consisting of rice, moong dal, seasonal vegetables, soybean chunks, secret Masada of chef speciality cooked with affection. Hand Gloves, Masks, and all other safety measures like aprons are used along with sanitisation to maintain hygiene. Such tasty food served hygienically in a clean disposable bowl with spoon to eat. About two of our faculties and respected Vice Principal madam also from the NGO “A HAND” Mr. Yasir Ismail, Sohail Ismail, Md Anwarus Sayeed, Abdul Qadar, Mr. Hossain, were present at the spot and also actively participated in the food distribution camp. Few sincere and kind students joined us. Moreover, support of the organizing team was worth mentioning to make this camp successful.

Lastly our honorable madam handed over a contribution of Rs 2000 in Cash to the NGO “A HAND” from Teachers Council of Surendranthan law college.

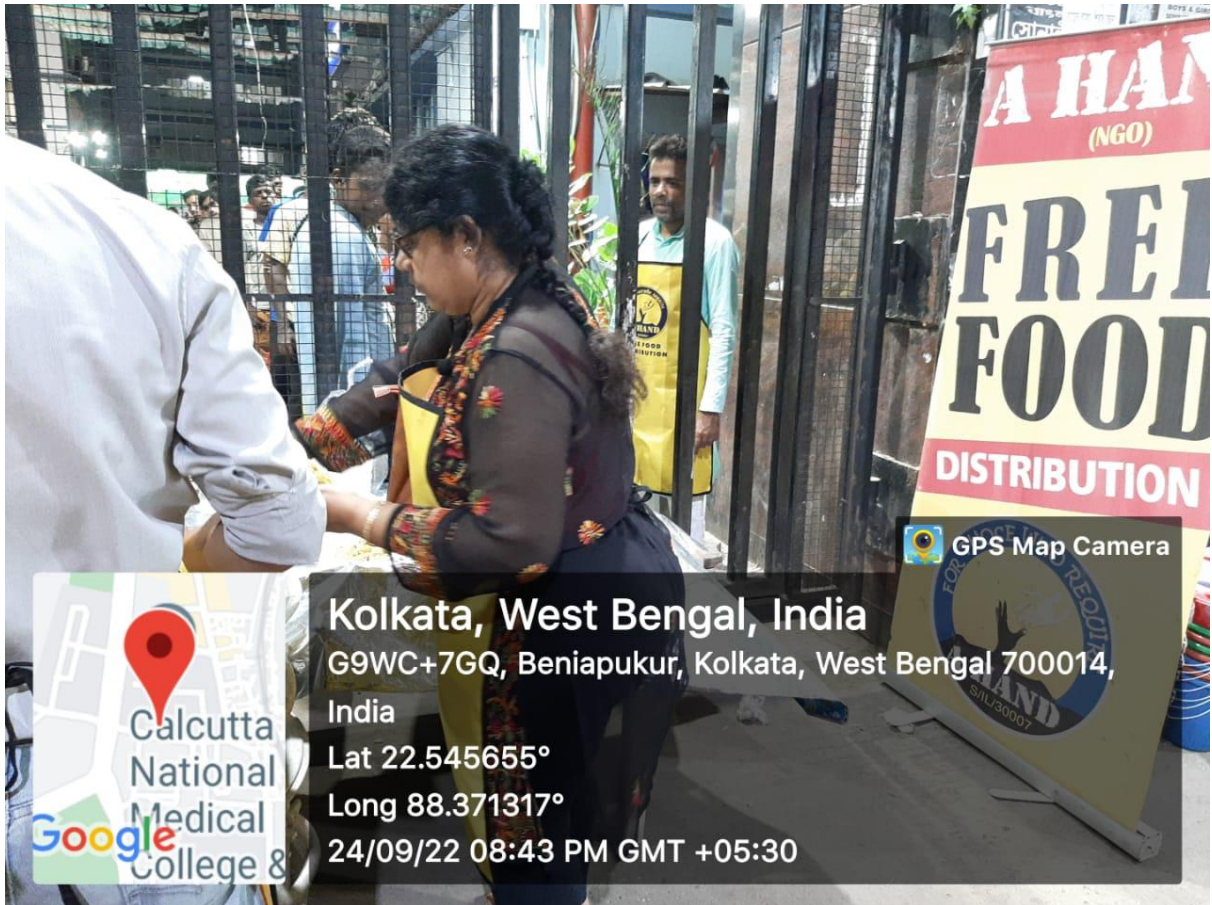
