Surendranath Law College is an esteemed law institute affiliated to the University of Calcutta and recognized by the Bar Council of India, also regarded as one of the oldest law colleges of the country. In 1882, the Presidency School, which formed the nucleus of the present Institution, was handed over to Sir Surendranath Banerjea on 1st January 1884. He raised it to the status of a college affiliated to the F.A. standard and named it “The Presidency Institution”. Within a year the institution was converted into a full-fledged, first grade college under the name “Ripon College”. Its activity was further extended through the opening of the Post-Graduate Department of Law in 1884, which was later affiliated to the Calcutta University in the year 1885, as an independent professional college. Presently, Surendranath Law College imparts 5 years B.A.LL.B. course, 5 years B.A. LL.B. (Honours) course and two years LL.M. course.
