

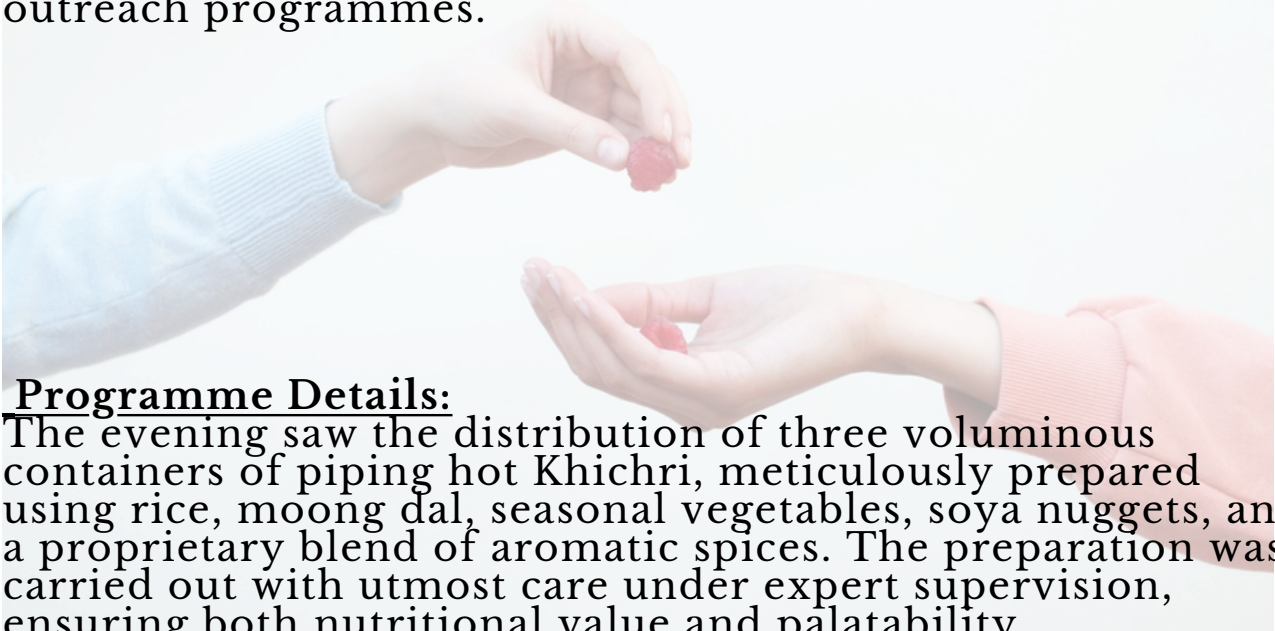

To Strengthen Institutional Outreach: To enhance the college's role in community engagement by collaborating with NGOs working at the grassroots level. 4. To Uphold Hygiene and Safety: To ensure safe and hygienic food distribution by adhering to proper sanitisation protocols and using protective gear and disposable serving materials. 5. To Promote Volunteering Culture: To inspire a spirit of regular philanthropy and social service among the college community through continued involvement in monthly outreach programmes.
