



## **Lecture Series on Alternative Disputes Resolution (ADR) for 10<sup>th</sup> Semester Students -2022**

Alternative Dispute Resolution System (ADRs) refer to a wide range of procedures through which disputes between the parties are settled or brought to an amicable result without the intervention of a Judicial Institution and without any trial. These methods usually involve a third party mediator which facilitates the dispute resolution between the two contesting parties. Alternative Dispute Resolution mechanism provides scientifically developed techniques to the Indian Judiciary which helps in reducing the burden on the courts. ADR provides various modes of settlement including arbitration, conciliation, meditation, negotiation, and Lok Adalat.

Surendranath Law College, an esteemed Law college, affiliated to the Calcutta University in 1885, imparting UG education since 1885, organized a series of lectures for the 10<sup>th</sup> Semester Students on the topic “**Alternative Dispute Resolution System**” on **11<sup>th</sup> to 13<sup>th</sup>, 22<sup>nd</sup>, 25<sup>th</sup> & 26<sup>th</sup> April 2022** at the Seminal Hall of Surendranath Law College which was counseled by **Prof. Dr. Mohammadi Tarannum**, Vice-Principal of the Surendranath Law College at college premises.

This series of lectures greatly benefitted the students in grasping the various the Acts which deal with Alternative Dispute Resolution such as the Arbitration and Conciliation Act, 1996 and,

The Legal Services Authority Act, 1987. Students got to know that the ADR is Cost effective method: it saves a lot of money if one undergoes the litigation process. Students also got to know that Section 89 of the Civil Procedure Code, 1908 provides that opportunity to the people, if it appears to the court there exist elements of settlement outside the court then the court formulate the terms of the possible settlement and refers to the same for Arbitration, Conciliation, Mediation or Lok Adalat.

The Lecture Series was scheduled for 11<sup>th</sup> to 13<sup>th</sup>, 22<sup>nd</sup>, 25<sup>th</sup> & 26<sup>th</sup> April 2022 at Seminar Hall of Surendranath Law College.
