### **ABOUT THE COLLEGE**

Within a year the institution was converted into a full-fledged, first grade college under the name "Ripon College". Its activity was further extended through the opening of the Post-Graduate Department of Law in 1884, which was later affiliated to the Calcutta University in the year 1885, as an independent professional college. Surendranath Law College imparts 5years B.A.LL.B. course, 5years BA. LL.B. (Honours) course and two years LL.M. course.

- **ABOUT THE COURSE**

Cardiopulmonary resuscitation (CPR) is an emergency lifesaving procedure that helps restart a person's heartbeat and breathing when they stop. It is used when someone is unresponsive and not breathing or gasping for air. Immediate CPR can double or triple chances of survival after cardiac arrest. CPR involves:

Chest compressions - Rapidly pushing on the chest to keep blood moving. The American Red Cross recommends 100 to 120 compressions per minute.

Rescue breathing - Blowing air into the person's mouth to help them breathe and send oxygen to their lungs.

CPR techniques vary depending on the age and size of the person. If you haven't been trained in CPR, you should continue chest compressions until the person moves or emergency medical help arrives.
