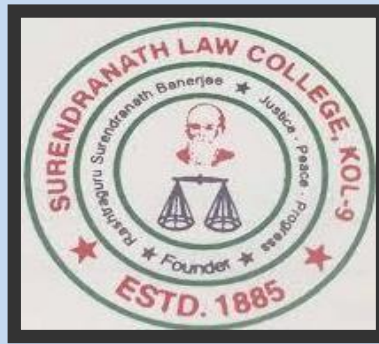

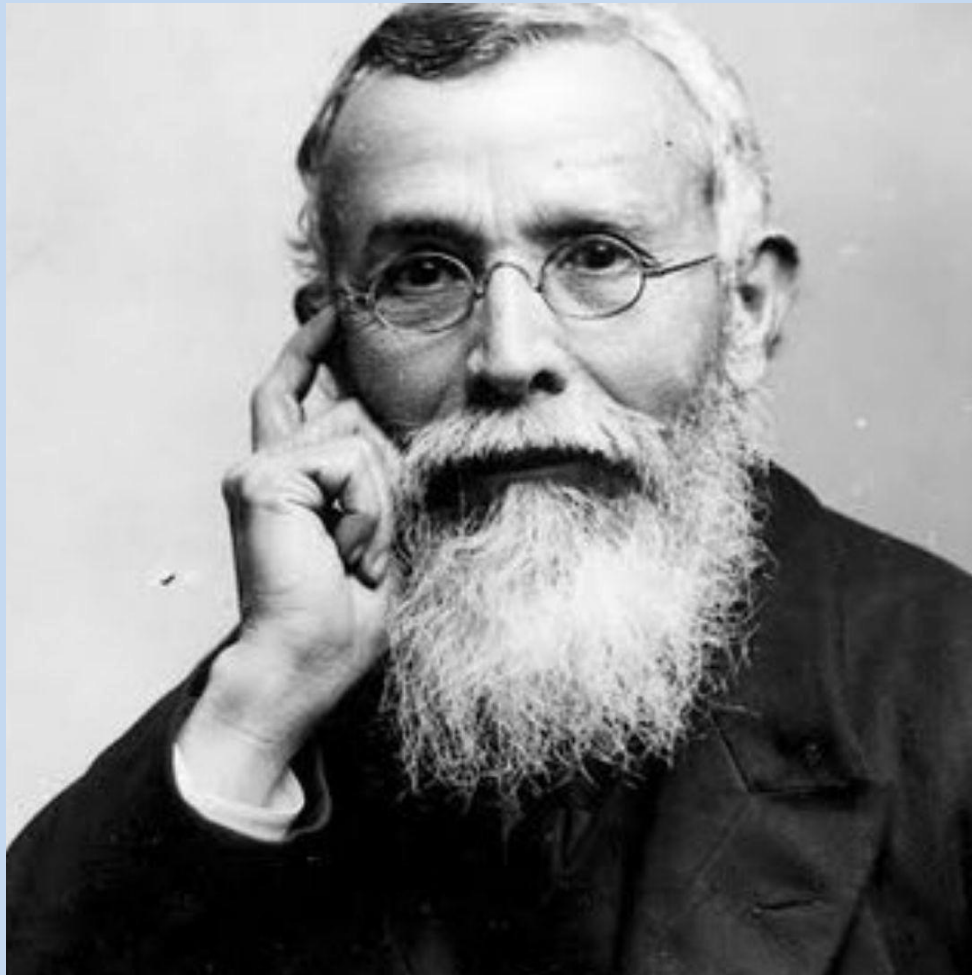

1. Glorious History of the College:

a) The Founding Father - Sir Surendranath Banerjea

Sir Surendranath Banerjea (November 10, 1848 – August 6, 1925) needs no introduction as a great patriot, political leader, orator, teacher, educationist and journalist. ‘Rastraguru’ Surendranath Banerjea established Surendranath Law College at the heart of Kolkata city, near Sealdah Station in 1884-85. This is a reflection of his illuminating vision to make quality education accessible to all, by strategically establishing the campus at a distance that is easily commutable by train. As the founder of this prestigious institution, his noble idea of bringing higher education within the reach of the widest possible sections of the society continues to remain the guiding motto of the college. His profound thought of encouraging more students, especially those belonging to the down-trodden community, to partake of quality education speaks volumes about his commitment as a fine educationist and a personification of the guardian of human values and social justice.

b) The Establishment - A Brief Historical Account

In 1882, the Presidency School, which formed the nucleus of the present Institution, was handed over to Sir Surendranath Banerjea on 1st January 1884. He raised it to the status of a college affiliated to the F.A. standard and named it “THE PRESIDENCY INSTITUTION”. Within a year the institution was converted into a full-fledged, first grade college under the name “RIPON COLLEGE”. Its activity was further extended through the opening of the Post-Graduate Department of Law in 1884, which was later affiliated to the Calcutta University in the year 1885, as an independent professional college. Since then, as long as he lived, Sir Surendranath not only remained at the helm of affairs, but was also active as a teacher, in the college. Sir Surendranath attached the name of Lord Ripon to his Institution as a tribute to the enlightened policies of the Viceroy. But after the attainment of independence, the golden cause to which Sir Surendranath dedicated his entire life, the name of the college was altered to Surendranath College. This was done to commemorate Sir Surendranath who had established this pioneering institution and nurtured it with utmost love and dedication. Surendranath Banerjea was the absolute owner of Ripon College (now Surendranath College) and Ripon Law College including the Collegiate School up to 1908. With the aim of placing the Ripon Group of Institutions on a permanent footing and affiliating them to public institutions, Surendranath Banerjea, the proprietor, thought it desirable to divest himself of all private rights of property that he had over the said institutions and vesting them with a Public Charitable Trust in the year 1909. The first signatory of the Trust deed

was Surendranath Banerjea himself. Other prominently notable personalities and educationists among the signatories were, Satyendra Nath Mukherjee, Upendra Nath Mukherjee, Jogesh Chandra Choudhury, Rashbehari Ghosh, Ashutosh Chaudhuri, Baikuntanath Sen, Baron Sinha of Raipur, Bhupendranath Basu and Ramendra Sundar Trivedi. After 1948, at instance of the Hon'ble Chief Justice of the High Court at Calcutta, the Ripon Group of Institutions was renamed after Rashtraguru Surendranath Banerjea; and came to be known as Surendranath Law College. Surendranath Law College has stood the test of time and contributed to nation-building by responding to the needs of time and society in all its earnestness. During the Partition Movement in 1905 and 1942, many teachers and students from the college actively protested against the wrongful act of partition and willingly sacrificed their lives for the noble cause. Many students were arrested by the British Police from Ripon Hostel attached to the college. In fact, the sense of nationalism and patriotism were genuinely inculcated amongst the students by their teachers. The college has moulded distinguished luminaries such as Dr. Rajendra Prasad, the first president of India; Harendra Kumar Mukherjee, the first Governor of West Bengal, Justice Bijan Kumar Mukherjee, the first Chief Justice of the Supreme Court of India and many other eminent personalities.

c) Upholding the Legacy of Academic Excellence and Noble Sacrifice

Surendranath Law college offers a 5-year B.A. LLB, B.A. LLB (Honours) and LL.M. The 5-year LL.B. Course was introduced since 1987 with renewed vigour and infrastructural change. Presently there are approximately 800 students studying under different programs. The college has been maintaining a trend of high rate of success in the university examinations for a considerable period of time. Students of this college have been serving successfully in fields of legal calling ranging from Judicial Service, Legal Service, Academics, Banking and Corporate jobs and advocacy. It is also one of the oldest law colleges in India.

The college organizes various programmes with a balanced and holistic approach to mould students with the spirit and ideals of the founder and other nationally acclaimed personalities that have graced the college. Students from our college have made the institution proud through academic brilliance by securing gold medals in their respective course of study. Not just in academics, students have made holistic progress through brilliance in sports and all extra-curricular activities at both the state and national level. Our students have participated in and excelled in All India Moot Court competitions held in different parts of the country. As part of its

commitment to social justice and responsibility, students and teachers jointly organize awareness generating camps in the locality to help people to fight social maladies and evils. With the help of the Directorate, various NGOs, and the Government of West Bengal, the students have successfully organized Consumer awareness campaigns, anti-pollution campaigns, Legal-aid Campaigns, Social Outreach activities and AIDS, Drug-abuse prevention campaign in the city. Keeping in view the philosophy that change is the only constant in the world, the college is always open to modulating Value added courses to empower students with the skills needed to face the challenges of an ever-changing system of the present times.

Surendranath Law College, as a family together, celebrates dynamism and relentlessly strives to carry forward the rich legacy of quality education and excellence.

2. Vision and Mission

Surendranath Law College seeks to impart and advance quality legal education by engaging in teaching and dissemination of legal knowledge. The academic programmes and activities of the college are prepared and executed keeping in mind the values enshrined in the vision of our founder Sir Surendranath Banerjee. This has developed among students a sense of responsibility to serve the society in the field of law.

The vision of the college is unique and in conformity with UGC guidelines and the regulations of the Bar Council of India making the path to its emergence as an eminent national and world-class institution with responsible governance and a sustainable future. The characteristic features of legal education as an instrumentality of social transformation and upholding of constitutional values and human rights ethic is intrinsic to its objectives. An inclusive and diverse approach reinforcing gender parity and social inclusion is an affirmation of the institutional vision. Updated curriculum, innovative teaching methodologies, and inquiry/ experiential-based learning provide the necessary stimulus for cutting-edge skill sets and constructive mindsets. The research component of legal education is an emerging factor that highlights the doctrinal/empirical potential and its realization. It is integral to the academic vision of the institution having its indelible impact on law and policy reform.

The vision of the college incorporates the objective of imparting comprehensive legal education which is socially relevant. The legal and ethical values enshrined in the Constitution of India, and its objectives of achieving political, economic and social justice serve as the foundation of all academic pursuits in the college.

The mission of Surendranath Law College is to facilitate the dissemination of legal education of the highest standards to its students on the implications and applications of law within changing social context. The college aims to achieve the following as a part of its noble academic mission

- Empowerment of students through imparting high quality legal education training, skill, and research.
- Empowering students for accepting new challenges in social, economic, and legal domains by transforming them into competent professionals, and participate in public governance and administration.
- Enabling students to acquire qualities of accountable leadership with integrity, honesty and compassion.
- Enabling students to acquire the requisite domain expertise regarding the interface between law, science, and technology.
- To foster the spirit of innovation in teaching, learning and community service.
- Collaborating with other institution of repute in higher learning in the domains of legal education, training and research in law, justice, social development, and allied subjects.

3. Institutional Development Plan

The Surendranath Law college has been continuously working on developmental aspects of the institution on different fronts in view of imparting quality legal education. The areas of focus include development of the library, initiative on green & disable friendly campus, use of modern technologies and learning tools in class rooms, use of renewable energy resources, introduction of unique and career-based add-on courses, skill development and value education programmes, organising regular moot court competitions and legal-aid camps etc. Accordingly, the IQAC of the college proposed a number of initiatives to be implemented in near future.

- The college has a well-equipped library containing books and journals of high academic standards catering to the academic and research needs of the students and faculty. There are plans of future upgradation of the library by subscribing to reputed online journals and creating a database to facilitate legal research. There are plans to add in the number of existing computers in the library for smooth access of online resources by the students and faculty members.

- The Government of West Bengal has allotted a land measuring about 51 kothah to the College in Newtown Rajarhat area and the land is already registered in the name of Surendranath Law college. The College aims to start its new campus in near future.
- The new college campus would be conforming to green building code of environmental sustainability and preservation. There would be the provisions of solar roof top panels, rain water harvesting, energy conservation, disable friendly equipment in the new campus. The college aims to establish in future separate hostels for boys' and girls' students.
- The college conducts various certificate courses for students and its alumni for the enhancement of various professional as well as soft skills, which are indispensable for the 21st century knowledge economy. The college also started organising value education courses with help of its MoU partners. At present the college conducts 9 value added courses (VAC). In future the college seeks to increase the number of value-added courses by launching industry relevant courses for the lawyers' community pertaining to arbitration, cyber law, maritime law, medical jurisprudence etc.
- Dedicated sports facilities catering to both indoor and outdoor games would be established which would play a pivotal role in the holistic vision of attainment of both physical and cognitive development of the students.
- The career counselling cell would be made more effective to facilitate the opportunities such as internships in prestigious law firms for the students of the college. The career counselling cell would also play an instrumental role in creating collaborations with professional institutes for developing opportunities of internship and placement of the students.
- The college aims to strengthen the research cell to foster the spirit of innovation in emerging domains of law such as digital law, cyber security, AI (artificial intelligence), to name a few besides undertaking analyses in traditional legal domains.
- Well-equipped information technology infrastructure would be created along with the subscription of the best of national as well as international legal academic resources to further the endeavour of academic excellence and foster the spirit of research and development of all stakeholders of the college.
- The college with the aim of securing the career prospects of students, seeks to establish in future a dedicated centre imparting guidance for competitive examinations such as judicial services exams, UGC-NET, & civil services.

- The college shall actively pursue collaborative ventures with other reputed institutions of higher learning to inculcate legal awareness amongst students on foundational concepts of constitutional law, human rights, duties and obligations of an Indian citizen.
- The college aims to obtain necessary affiliation to offer Ph.D. courses in future in various disciplines law.
- A psychological counselling centre under the supervision of trained psychologist would be created for the purpose of conducting various workshops related to stress management, developing emotional quotient, and sensitising students, faculty and legal professionals.
- The college has a coherent policy on faculty retention and faculty development. The College has been reviewing the policy so that the faculty is actively encouraged to participate in seminars, conferences, symposiums for enhancement of their academic and research credentials. The college plans to increase the conducts various workshops for skill upgradation & personality development of its faculty members.

4. Institutional Distinctiveness

The goal of Surendranath Law College is to give students a comprehensive legal education that will enable them to become more knowledgeable and skilled advocates in many contexts.

Knowing how important it is for students to develop their leadership abilities, Surendranath Law College makes sure that as many of its students as possible are on committees, which encourages them to participate in the various events that are organized.

Surendranath Law College also makes an attempt to identify the learning level of the students in the first semester. A bridge course for newly admitted students is conducted every year before the commencement of the first semester classes. The purpose of this Course is not only to bridge the gap between subjects studied previously and the subject to be studied in the programme, but also to clarify and revise the fundamental concept of the course.

Practicing advocates, legal luminaries, academicians and Non-Governmental Organizations are invited to deliver the lectures. The seminars and guest lectures are organized every month in order to inculcate a sense of learning and research habits amongst the students.

There are various committees and cells in the college, like grievance redressal cell, eco club, debate and quiz club, cultural committee, placement cell, anti-ragging cell, extension activity committee, moot court club etc. and these clubs and committees perform various programmes throughout the year. Besides, various important days like Independence Day, Republic Day, Teachers' Day,

National Youth Day, Constitutional Day, Forest Day, International Mother Language Day, International Women's Day etc are also observed. College also organizes blood donation camp, legal aid camp, road safety awareness, traffic awareness camp, community health check up camp, tree plantation, adventure camp, environment awareness programme, awareness programmes on drug addiction, child labour etc. and other such activities every year to provide for creative inclusive environment. The college has a legal aid club and with collaboration with District Legal Services Authority, Kolkata, free legal aid and legal assistance are given to the adjacent people every Tuesday in the college campus. Besides, legal aid camp has also been organised by the college in the remote areas. The college also take part in various extension activities, like free food and clothes to the poor, visit to old age home etc.

Keeping the ever-changing trend, ICT based teaching methods and infrastructural development has been followed.

The Institution has a prescribed code of conduct displayed on website. Committee monitors its adherence.

The College has taken initiatives to organize Seminar, Webinars, Workshop, Sensitization Programme, Faculty Development Programme, awareness programme on sexual Harassment etc. College has also introduced the Value-Added Certificate Course on various topics which are covered by the curriculum. The College has made various MoUs with other academic institution and NGOs to exchange the students and faculty as well as other research activities.

The slow learners are provided with remedial lectures to help them in solving their difficulty in understanding different concepts. Hence, our Institution conducts such activities to cater to the needs of the students and also to ensure their Holistic Development.

Notification No. CSR/23/11

It is notified for the general information of all concerned that the syndicate in its meeting to the existing Regulations (as notified under Notification No. CSR/87/09 dated 22.12.2009 held on 23.03.2011 (Item No. 22) approved the following modifications/incorporations to be effective from the Academic Session 2009-2010.

The modifications are as follows:

- A candidate may only appear at a single Examination as a Supplementary Examination along with any other/higher Semester Examination. 3) A candidate who is unsuccessful in a paper, has to reappear at the said Practical or Internal Assessment Examination.
- A candidate may appear at higher Semester examination without appearing lower Semester.
- A candidate may continue his/her course of study for the next higher Semester without appearing lower Semester.

Regulation 18 as modified:

"Back paper examination: If a candidate appears in all papers but fails to secure 30% marks in not more than two papers or less than 40% marks in aggregate in any semester he will be allowed to appear in not more than two papers along with the examination of higher semester. A candidate will be allowed to appear in such examination [said papers only] only for two consecutive chances (excluding the main chance) to pass the respective semester.

However, a candidate failing to clear a particular semester within the said stipulated chances, shall have to leave the course.

Such candidate shall be promoted to the next higher class if he fulfils the requirements of the attendance of class."

Regulation 19 as modified:

Candidates appearing the examination as a whole may apply in the prescribed form for the post publication Re-examination of their answer scripts in not more than two theoretical papers provided that they have secured at least 35% marks in aggregate of the remaining papers taken together.

Regulation 24 as Incorporated:

GRACE MARKS:

"A candidate failing to obtain the pass marks in a semester examination shall be given benefit of one additional mark in the paper in which he secures lowest marks and the same shall be shown in the Tabulation Roll. However, in the mark sheet, only the total marks shall be shown after such addition.

A candidate failing to obtain on 50% or 60% marks in the aggregate of all the semester by one mark only, shall be given the benefit of one additional mark in the result of the final semester and the same shall be reflected both in the Tabulation Roll as well as in the mark sheet. A candidate who is unsuccessful in a paper has to reappear at the said Practical or Internal Assessment Examination."

- 4) **Foreign Student** : Foreign National with last qualification eligibility degree from Foreign Board have to apply in writing to the undersigned mentioning all previous degrees, mark sheets, certificates and syllabus of the last qualifying examination eligibility degree, High Commission Forwarding and AIU Equivalence Certificate . After preliminary verification they may be called for interview. If qualified in interview the C.U. equivalence certificate has to be collected. After getting equivalency clearance a provisional list will be prepared for approval of Vice-Chancellor, C.U. Lastly selected candidates will get admission with all required documents.

Foreign National with last qualifying eligibility degree from Indian universities/boards candidates may also apply as like other Indian national candidates.
